### Description

The MBA in Corporate Governance at the University of Professional Studies, Accra, prepares professionals to promote transparency, accountability, and sustainable success in organisations. Blending advanced study in governance, law, finance, and management with practical boardroom skills, the programme equips students to advise boards, shareholders, and stakeholders on compliance and best practices. Core modules such as Corporate Governance: Theories and Issues, Corporate Secretarial Practices, and Company Compliance and Administration develop expertise in statutory obligations and governance processes, while courses in Company and Partnership Law and Corporate Financial Analysis and Business Valuation strengthen legal and financial proficiency. Specialised studies in Internal Audit and Controls, Enterprise Risk Management, and International Corporate Governance expand understanding of global risk and compliance systems. Electives in Business Sustainability and Boardroom Dynamics address contemporary governance challenges, complemented by core business courses in strategy, organisational behaviour, finance, marketing, and economics. Through the Practitioners' Forum and Project Work, students refine their professionalism, research ability, and applied governance insight under the mentorship of industry leaders. Graduates emerge prepared for leadership roles as company secretaries, governance experts, compliance managers, risk consultants, and board advisers across sectors, equipped to reinforce governance frameworks and guide strategic decisions that strengthen organisational resilience and societal trust.
